The Council of Legal Education invites applications from Attorneys-at-Law qualified to practice law in the Commonwealth Caribbean for the posts of **Tutor (Teaching and Learning)** at the Norman Manley Law School, 8 Ring Road, and its Legal Aid Clinic, 18 Gibraltar Hall Road, UWI Mona Campus, Kingston 7, Jamaica, W.I.

Applicants must have at least five (5) years of practical and professional experience. The position is full-time and no outside employment may be undertaken without the prior approval of the Principal of the Norman Manley Law School. The appointment will be on contract for three (3) years in the first instance and is renewable.

Knowledge of the laws of the Commonwealth Caribbean is essential. Applicants are expected to have experience in the use of information and communications technology to facilitate the performance of assigned duties and responsibilities.
