Legal Education Certificate - Two Year Programme

Applications are invited from holders of a first degree in Law obtained from a recognized institution in a common law jurisdiction (in accordance with Article 3 of the Treaty Establishing the Council of Legal Education), or holders of the Common Professional Examination Certificate or Graduate Diploma in Law (GDL) from a recognized institution (UK) together with vocational training, and who wish to be considered for selection for the Two-Year Legal Education Certificate Programme.

The GDL on its own is not considered by the Council of Legal Education (the Council) to be equivalent to the UWI LL.B Degree and therefore, does not qualify you for entry to any of the Council's schools. In order to qualify for entry, the GDL must be accompanied by evidence of formal vocational training, such as Bar exams, or the Solicitors Final Examination.

For the 2025/2026 academic year, the examination will be replaced by an evaluation of the transcript of the Applicant's Bachelor of Laws (LLB) degree. This is in order to ensure that, in accordance with the requirements of Article 3 of the Agreement Establishing the Council of Legal Education, 1971, the degree is recognized as equivalent to the LLB from the University of the West Indies. The LLB degree of each applicant will be ranked in order of the Class/GPA for purposes of determining priority for placement at one of the Council's law schools, WHICH IS SUBJECT TO SPACE AVAILABILITY.

This is not applicable to holders of the University of the West Indies LL.B. degree.

Stale Degrees

A UWI LL.B, or a degree from a university or institution that is recognised by the Council of Legal Education as equivalent to that degree, which is ten or more years old, is deemed stale. Applicants with stale qualifications will be required to provide details of any practical experience garnered during that period between the award of the degree and their application to the Law Schools before applying to the Law Schools.

Applicants to any Law School who are unable to provide proof of practical experience will be required to successfully complete an entrance examination which would test knowledge of the core subjects before they are admitted.
